**a.** Safety Committee Presentation and request for staff participation – Jacob LaCroix, EMS instructor.

**b.** Staff Council Budget Presentation - Jayme McMahon, Director of Student Affairs and Administrative Liaison.

Discussion: McMahon gave presentation on Staff Council budget. There is no money currently available in the Staff Council index, but historically \$750 has been allocated per year. McMahon recommended



thinking about goals and how to support those financially, then present a budget request to the administration. She said there is also a separate checking account with Washington Federal that holds approximately \$1,200. McMahon recommended closing that account and moving funds to Staff Council index. Fundraising and solicitation policies were brought up. President Sanchez asked if McMahon could give a presentation or training to the Staff Council, and McMahon agreed. Action: None.

c. Staff Council Wellness Committee - Frank Sanchez.

Discussion: Sanchez said new workgroup is focused on gym and wellness initiatives and is making significant progress with new exercise classes starting. Sanchez said progress is also being made on a World of Wellness program similar to ABQ campus.
