# F80: Representation on Faculty Senate and Its Committees

#### POLICY RATIONALE

The Faculty Constitution affirms the rights of branch community college faculty to be represented in the Faculty Senate and to decide upon the procedure best suited to the efficient functioning of the branch community college.

#### POLICY STATEMENT

Branch community colleges shall have representation on the Faculty Senate and its Standing Committees in accordance with the procedures established by the Faculty Senate and its component committees. Faculty at branch community colleges shall have the right to create faculty governance bodies on their campuses, provided those assemblies do not conflict with the authority and functions of the Faculty Senate described in the Faculty Constitution.
