**INFORMATION TECHNOLOGY** 

Gill Gonzales

Dr. Gonzales understands there are challenges and he is open to returning to Gallup at the faculty request to continue to discuss these issues.

#### <u>List of issues/challenges faculty expressed:</u>

- WebCT how to consistently deploy all application resources
- Wireless not reliable, requires extra configuration and can be a burden, the process to get to the wireless can be tedious and in some cases it is not available and unable to login.
- Allocation of services/resources is not consistent across the campus No baseline
- No or limited support for MAC computers
- IBM user cannot print from classrooms
- Work Order system is not efficient nor reliable
- There are numerous older computers that need an upgrade. Told by IT faculty would have to wait for five years before qualifying for an upgrade
- Gil asked if there is a refresh program. Faculty replied We are told there is, but it does need
  to be clarified

- Gil asked faculty if they feel that IT has integrity. Consensus was no.
- Wireless & network connection in Zuni would help accommodate Gallup faculty.
- Gil inquired do you want to go between sites and have same login? The idea of being able to
  move between physical spaces is important to faculty, as well as, printing anywhere and
  sharing files.
- Student computing and Student printing. It is changing; we deal with very technical student now. There is no control of resources, i.e., printing by students; it is costing the department.
- Have a better connection with UNMA Website and display schedules as one organization. One single catalog.
- Student email accounts have to login to UNMA to check their email here. Gil this is a larger issue at UNMA, which currently has over 200 emailing systems.
- Marketing- Gallup cannot be found on Albuquerque's Website.
- · Students need their own individual login and ID
- Library access from proximity
- Wireless guest into Gallup is a problem
- Smart Classroom technology. Gil need to do some planning on what they do and how to use them
- Gil asked about a faculty technology committee. Faculty replied yes there is one, but it is not
  effective and dissolved by previous interim director, due to the fact that recommendations
  were not being addressed.
- Administrative privileges are a burden on faculty. Gill this is an area of contention and continues to be addressed.
- Software IT often says no, because they do not want to support it.
- Students have text software and cannot use it in the lab, because they won't work and IT has not addressed this issue. Same situation with flash drives. Instructional software not available.
- IT in new building discussed
- Gil suggests getting all classrooms in a database and address what technology is in there and how often it needs to be updated. Same thing with the remodeling.
- Gil Most important, is IT creating support so that students can be successful.
- Password security do they have to be changed every 6months. Gil yes, they do need to change to deter individuals from breaking into them, would suggest that this is a good topic to discuss privacy and security. Could request UNMG It to extend the six month window.

#### To summarize:

Five things to work on:

- 1. Access to secure network
- 2. Access to applications, such as UNMA resources
- 3. A seamless way to incorporate video applications
- 4. Have a coherent, logical IT plan from this Campus. One that a budget committee can support. This is urgent.
- 5. Convenient and consistent service with an open door policy (not a locked door keep out policy).

Gil – these five items will be the five agenda items for the next semester. Need to consider a very serious success criteria to know when they are achieved.

This means the student will need to spend less time with the advisor, because they would have already taken care of some of these requirements with the peer advisor.

The development of an advisor feedback tool is in process. This tool will be used to see what the student experience was with the advisor. This feedback will help the advisor to have accountability. Ralph Casebolt suggested that we might want to utilize this tool with faculty advisors also. Academic advisors should be attending the respective instructional department meeting to keep abreast and informed.

We will need to take another look at the Advising Taskforce Document and follow through with its recommendations.

Possible 2% salary cut for state workers is not expected to effect education.

Dr. Andrew had anticipated presenting a draft plan for campus realignment this week but cannot due to her absence from campus to be with her family. Draft proposal now expected by spring break and will be presented to campus.

## Student Service/Enrollment Update

Information/ Discussion

Early registration is working: In Spring 08, 47 students registered early, 230 this year. Credits enrolled early previously 395, currently 2180. Online and early registration and contribution of faculty assistance made this a success.

At this time, we are also up in credit hours 18.7%, up in head count 17.5%, from same date last year.

Extra effort will be made to insure that students needing financial support will receive it.

Efforts being made to bring personal counseling to campus. Discussions with Western have begun to work out some sort of internship with their counseling program. All is preliminary now.

We are still looking for ways to offer and encourage alcohol and drug counseling. This is still in its earliest stages and much more needs to be done.

## **Adjunct Faculty Task Force Report**

Task Force formed last fall to examine issues and concerns unique to adjunct faculty, develop recommendations to send forward. 60% of all instruction done by adjuncts on campus.

Recommendations include: instructional support in evening; compensation, with suggestions/ requests including merit based pay increases, long-term contracts (longer than semester-by-semester), reinstate tuition waiver; greater communication and representation, including an adjunct Faculty Senate, representation on task forces and committees; orientation for adjuncts by chairs of each department and a mentoring program; increased opportunities for professional development.

Discussion will continue with the management team to find possible solutions.

#### **Comments about Rumors**

Dr. Dyc took the opportunity to dispel rumors that she was behind a vote of no confidence in Dr. Andrew.

Members of the Faculty Senate Operations Committee and Jim Sayers have also been implicated in rumors concerning a supposed move for a vote of no confidence in the Executive Director, and took the opportunity to speak out as well.

The Operations Committee has never once discussed or considered a vote of no confidence in the Executive Director. We have only looked for ways to continue positive, forward progress. No member of the faculty has ever approached the Operations Committee to consider a vote of no confidence. It is nothing but a rumor meant to divide and distract us from working together to move our campus forward.

When he first heard such rumors in the Fall, Dr. Bush met with the Executive Director personally to tell her there was no truth to them. They were nothing but rumors. Dr. Bush stated that there is room for disagreement on campus without resorting to rumors. We don't all agree but can do so professionally. We shouldn't be choosing sides, because we are all in this together and there are no sides.

## **Report from the Executive Director**

Information

Dr. Andrew responded to the mention of these rumors by stating that the Faculty have a right to a vote of no confidence because of academic freedom, but there would be a lot of questions concerning one because of the short duration of her tenure here so far.

Budget Information – There is an \$11 million difference between the amounts before the House and the Senate. The state is looking at a shortfall of \$650 million overall, and education won't suffer much in comparison to that. Reorganization draft plans will show how the budget could be reduced by eliminating duplication.

Internal Audits – Any results of these will be made public.

Dean's Search – Paul Kraft is the chair of the committee. There is a March 1st deadline for applications.

IT Audit – Our capacity has not kept up with need for services. The audit was meant to examine ways to strengthen IT. For instance, there is no security plan in place, etc. Outside input was needed.

PCDC – Guidelines are coming out shortly and the forms have been updated. The deadline for new applications is March 1<sup>st</sup>.

Reorganization – Planning on this was thrown off because of an unexpected absence. A draft is underway and will be presented to the management team before it comes to the Senate. We will have a meeting on the proposed reorganization the week after Spring Break where all can comment. There may be some HR implications.
