#### Abstract

: In this paper we have suggested two classes of estimators for population median $M_{Y}$ of the study character Y using information on two auxiliary characters X and Z in double sampling. It has been shown that the suggested classes of estimators are more efficient than the one suggested by Singh et al (2001). Estimators based on estimated optimum values have been also considered with their properties. The optimum values of the first phase and second phase sample sizes are also obtained for the fixed cost of survey.

## 1. INTRODUCTION

In survey sampling, statisticians often come across the study of variables which have highly skewed distributions, such as income, expenditure etc. In such situations, the estimation of median deserves special attention. Kuk and Mak (1989) are the first to introduce the estimation of population median of the study variate $Y$ using auxiliary information in survey sampling. Francisco and Fuller (1991) have also considered the problem of estimation of the median as part of the estimation of a finite population distribution function. Later Singh et al (2001) have dealt extensively with the problem of estimation of median using auxiliary information on an auxiliary variate in two phase sampling.

Consider a finite population $\mathrm{U}=\{1,2, \ldots, \mathrm{i}, \ldots, \mathrm{N}\}$. Let Y and X be the variable for study and auxiliary variable, taking values $Y_{i}$ and $X_{i}$ respectively for the $i$-th unit. When the two variables are strongly related but no information is available on the population median $\mathrm{M}_{\mathrm{X}}$ of X , we seek to estimate the population median $\mathrm{M}_{\mathrm{Y}}$ of Y from a sample $\mathrm{S}_{\mathrm{m}}$, obtained through a two-phase selection. Permitting simple random sampling without replacement (SRSWOR) design in each phase, the two-phase sampling scheme will be as follows:
(i) The first phase sample $\mathrm{S}_{\mathrm{n}}\left(\mathrm{S}_{\mathrm{n}} \subset \mathrm{U}\right)$ of fixed size n is drawn to observe only X in order to furnish an estimate of $\mathrm{M}_{\mathrm{x}}$.
(ii) Given $\mathrm{S}_{\mathrm{n}}$, the second phase sample $\mathrm{S}_{\mathrm{m}}\left(\mathrm{S}_{\mathrm{m}} \subset \mathrm{S}_{\mathrm{n}}\right)$ of fixed size m is drawn to observe Y only.

Assuming that the median $\mathrm{M}_{\mathrm{X}}$ of the variable X is known, Kuk and Mak (1989) suggested a ratio estimator for the population median $\mathrm{M}_{\mathrm{Y}}$ of Y as

where $\hat{M}_{Y}$ and $\hat{M}_{X}$ are the sample estimators of $\mathrm{M}_{\mathrm{Y}}$ and $\mathrm{M}_{\mathrm{X}}$ respectively based on a sample $\mathrm{S}_{\mathrm{m}}$ of size m . Suppose that $\mathrm{y}_{(1)}, \mathrm{y}_{(2)}, \ldots, \mathrm{y}_{(\mathrm{m})}$ are the y values of sample units in ascending order. Further, let t be an integer such that $\mathrm{Y}_{(\mathrm{t})} \leq \mathrm{M}_{\mathrm{Y}} \leq \mathrm{Y}_{(\mathrm{t}+1)}$ and let $\mathrm{p}=\mathrm{t} / \mathrm{m}$ be the proportion of Y , values in the sample that are less than or equal to the median value $\mathrm{M}_{\mathrm{Y}}$, an unknown population parameter. If $\hat{p}$ is a predictor of p , the sample median $\hat{M}_{Y}$ can be written in terms of quantities as $\hat{Q}_{Y}(\hat{p})$ where $\hat{p}=0.5$. Kuk and Mak (1989) define a matrix of proportions $\left(\mathrm{P}_{\mathrm{ij}}(\mathrm{x}, \mathrm{y})\right)$ as

with $\hat{p}_{i j}(x, y)$ being the sample analogues of the $\mathrm{P}_{\mathrm{ij}}(\mathrm{x}, \mathrm{y})$ obtained from the population and $\mathrm{m}_{\mathrm{x}}$ the number of units in $\mathrm{S}_{\mathrm{m}}$ with $\mathrm{X} \leq \mathrm{M}_{\mathrm{X}}$.

Let $\widetilde{F}_{Y A}(y)$ and $\widetilde{F}_{Y B}(y)$ denote the proportion of units in the sample $\mathrm{S}_{\mathrm{m}}$ with $\mathrm{X} \leq \mathrm{M}_{\mathrm{X}}$, and $\mathrm{X}>\mathrm{M}_{\mathrm{X}}$, respectively that have Y values less than or equal to y . Then for estimating $\mathrm{M}_{\mathrm{Y}}$, Kuk and Mak (1989) suggested the 'stratification estimator' as

where $\hat{F}_{Y}(y) \cong \frac{1}{2}\left[\widetilde{F}_{Y A}{ }^{(y)}+\widetilde{F}_{Y B}{ }^{(y)}\right]$
It is to be noted that the estimators defined in (1.1), (1.2) and (1.3) are based on prior knowledge of the median $\mathrm{M}_{\mathrm{X}}$ of the auxiliary character X . In many situations of practical importance the population median $\mathrm{M}_{\mathrm{X}}$ of X may not be known. This led Singh et al (2001) to discuss the problem of estimating the population median $\mathrm{M}_{\mathrm{Y}}$ in double sampling and suggested an analogous ratio estimator as

where $\hat{M}_{X}^{1}$ is sample median based on first phase sample $\mathrm{S}_{\mathrm{n}}$.

Sometimes even if $\mathrm{M}_{\mathrm{X}}$ is unknown, information on a second auxiliary variable Z , closely related to X but compared X remotely related to Y , is available on all units of the population. This type of situation has been briefly discussed by, among others, Chand (1975), Kiregyera (1980, 84), Srivenkataramana and Tracy (1989), Sahoo and Sahoo (1993) and Singh (1993). Let $\mathrm{M}_{\mathrm{Z}}$ be the known population median of Z .

Defining

such that $\mathrm{E}\left(\mathrm{e}_{\mathrm{k}}\right) \cong 0$ and $\left|\mathrm{e}_{\mathrm{k}}\right|<1$ for $\mathrm{k}=0,1,2,3$; where $\hat{M}_{2}$ and $\hat{M}_{2}^{1}$ are the sample median estimators based on second phase sample $S_{m}$ and first phase sample $S_{n}$. Let us define the following two new matrices as

where it is assumed that as $\mathrm{N} \rightarrow \infty$ the distribution of the trivariate variable ( $\mathrm{X}, \mathrm{Y}, \mathrm{Z}$ ) approaches a continuous distribution with marginal densities $\mathrm{f}_{\mathrm{X}}(\mathrm{x}), \mathrm{f}_{\mathrm{Y}}(\mathrm{y})$ and $\mathrm{f}_{\mathrm{Z}}(\mathrm{z})$ for $\mathrm{X}, \mathrm{Y}$ and Z respectively. This assumption holds in particular under a superpopulation model framework, treating the values of $(\mathrm{X}, \mathrm{Y}, \mathrm{Z})$ in the population as a realization of N independent observations from a continuous distribution. We also assume that $f_{Y}\left(M_{Y}\right), f_{X}\left(M_{X}\right)$ and $f_{Z}\left(M_{Z}\right)$ are positive.

Under these conditions, the sample median $\hat{M}_{Y}$ is consistent and asymptotically normal (Gross, 1980) with mean $\mathrm{M}_{\mathrm{Y}}$ and variance

In this paper we have suggested a class of estimators for $\mathrm{M}_{\mathrm{Y}}$ using information on two auxiliary variables X and Z in double sampling and analyzes its properties.

## 2. SUGGESTED CLASS OF ESTIMATORS

Motivated by Srivastava (1971), we suggest a class of estimators of $\mathrm{M}_{\mathrm{Y}}$ of Y as

where $u=\frac{\hat{M}_{X}}{\hat{M}_{X}^{1}}, v=\frac{\hat{M}_{Z}^{1}}{\hat{M}_{Z}}$ and $\mathrm{g}(\mathrm{u}, \mathrm{v})$ is a function of u and v such that $\mathrm{g}(1,1)=1$ and such that it satisfies the following conditions.

1. Whatever be the samples $\left(\mathrm{S}_{\mathrm{n}}\right.$ and $\left.\mathrm{S}_{\mathrm{m}}\right)$ chosen, let $(\mathrm{u}, \mathrm{v})$ assume values in a closed convex subspace, P , of the two dimensional real space containing the point $(1,1)$.
2. The function $g(u, v)$ is continuous in $P$, such that $g(1,1)=1$.
3. The first and second order partial derivatives of $g(u, v)$ exist and are also continuous in $P$.

Expanding $g(u, v)$ about the point $(1,1)$ in a second order Taylor's series and taking expectations, it is found that

so the bias is of order $\mathrm{n}^{-1}$.
Using a first order Taylor's series expansion around the point $(1,1)$ and noting that $\mathrm{g}(1,1)=1$, we have

where $g_{1}(1,1)$ and $g_{2}(1,1)$ denote first order partial derivatives of $g(u, v)$ with respect to $u$ and $v$ respectively around the point $(1,1)$.

Squaring both sides in (2.2) and then taking expectations, we get the variance of $\hat{M}_{Y}{ }^{(g)}$ to the first degree of approximation, as

The variance of $\hat{M}_{Y}{ }^{(g)}$ in (2.3) is minimized for

Thus the resulting (minimum) variance of $M_{Y}{ }^{(g)}$ is given by

Any parametric function $g(u, v)$ satisfying the conditions (1), (2) and (3) can generate an asymptotically acceptable estimator. The class of such estimators are large. The following simple functions $g(u, v)$ give even estimators of the class

Let the seven estimators generated by $\mathrm{g}^{(\mathrm{i})}(\mathrm{u}, \mathrm{v})$ be denoted by $\hat{M}_{Y i}{ }^{(g)}=\hat{M}_{Y} g^{(i)}(u, v),(i=1$ to 7$)$. It is easily seen that the optimum values of the parameters $\alpha, \beta, \mathrm{w}_{\mathrm{i}}(\mathrm{i}-1,2)$ are given by the right hand sides of (2.6).

## 3. A WIDER CLASS OF ESTIMATORS

The class of estimators (2.1) does not include the estimator

Proceeding as in Section 2 it is easily seen that the bias of $\hat{M}_{Y}{ }^{(G)}$ is of the order $\mathrm{n}^{-1}$ and up to this order of terms, the variance of $\hat{M}_{Y}{ }^{(G)}$ is given by

## 4. ESTIMATOR BASED ON ESTIMATED OPTIMUM VALUES

2. The function $\mathrm{g}^{*}\left(\mathrm{u}, \mathrm{v}, \alpha_{1}, \alpha_{2}\right)$ continuous in S .
3. The first and second order partial derivatives of $g *\left(u, v, \hat{\alpha}_{1}, \hat{\alpha}_{2}\right)$ exst. and are also continuous in S.

## 5. EFFICIENCY OF THE SUGGESTED CLASS OF ESTIMATORS FOR FIXED COST

The appropriate estimator based on on single-phase sampling without using any auxiliary variable is $\hat{M}_{Y}$, whose variance is given by

where $\mathrm{V}_{1}=\mathrm{V}_{0}\left(4 \mathrm{P}_{11}(\mathrm{x}, \mathrm{y})-1\right)^{2}$.
Putting these optimum values of m and n in the minimum variance expression of $\hat{M}_{Y}{ }^{(H)}$ in (3.6), we get the optimum $\min . \operatorname{Var}\left(\hat{M}_{Y}{ }^{(H)}\right)$ as

It is assumed that $\mathrm{C}_{1}>\mathrm{C}_{2}>\mathrm{C}_{3}$. The optimum values of m and n for fixed $\operatorname{cost} \mathrm{C}_{0}$ which minimizes the minimum variance of $\hat{M}_{Y}{ }^{(g)}\left(\operatorname{or} \hat{M}_{Y}{ }^{(G)}\right)(2.7)$ (or (3.4)) are given by

The optimum variance of $\hat{M}_{Y}{ }^{(g)}\left(\operatorname{or} \hat{M}_{Y}{ }^{(G)}\right)$ corresponding to optimal two-phase sampling strategy is

When N is large, the proposed two phase sampling is more efficient than that Singh et al (2001) strategy if $\operatorname{Opt}\left[\min \cdot \operatorname{Var}\left(\hat{M}_{Y}{ }^{(g)}\right)\right.$ or min. $\left.\operatorname{Var}\left(\hat{M}_{Y}{ }^{(G)}\right)\right]<\operatorname{Opt}\left[\min \cdot \operatorname{Var}\left(\hat{M}_{Y}{ }^{(H)}\right)\right\rfloor$

## 6. GENERALIZED CLASS OF ESTIMATORS

We suggest a class of estimators of $\mathrm{M}_{\mathrm{Y}}$ as

where $u=\hat{M}_{X} / \hat{M}_{X}^{\prime}, v=\hat{M}_{Z}^{\prime} / M_{Z}, w=\hat{M}_{Z} / M_{Z}$ and the function $\mathrm{F}(\cdot)$ assumes a value in a bounded closed convex subset $\mathrm{W} \subset \mathfrak{R}_{4}$, which contains the point $\left(\mathrm{M}_{\mathrm{Y}}, 1,1,1\right)=\mathrm{T}$ and is such that
$\mathrm{F}(\mathrm{T})=\mathrm{M}_{\mathrm{Y}} \Rightarrow \mathrm{F}_{1}(\mathrm{~T})=1, \mathrm{~F}_{1}(\mathrm{~T})$ denoting the first order partial derivative of $\mathrm{F}(\cdot)$ with respect to $\hat{M}_{Y}$ around the point $\mathrm{T}=\left(\mathrm{M}_{\mathrm{Y}}, 1,1,1\right)$. Using a first order Taylor's series expansion around the point T , we get

where $\mathrm{F}_{2}(\mathrm{~T}), \mathrm{F}_{3}(\mathrm{~T})$ and $\mathrm{F}_{4}(\mathrm{~T})$ denote the first order partial derivatives of $F\left(\hat{M}_{Y}, u, v, w\right)$ with respect to u , v and w around the point T respectively. Under the assumption that $\mathrm{F}(\mathrm{T})=\mathrm{M}_{\mathrm{Y}}$ and $\mathrm{F}_{1}(\mathrm{~T})=1$, we have the following theorem.

Theorem 6.1. Any estimator in $\mathfrak{J}$ is asymptotically unbiased and normal.
Proof: Following Kuk and Mak (1989), let $\mathrm{P}_{\mathrm{Y}}, \mathrm{P}_{\mathrm{X}}$ and $\mathrm{P}_{\mathrm{Z}}$ denote the proportion of $\mathrm{Y}, \mathrm{X}$ and Z values respectively for which $\mathrm{Y} \leq \mathrm{M}_{\mathrm{Y}}, \mathrm{X} \leq \mathrm{M}_{\mathrm{X}}$ and $\mathrm{Z} \leq \mathrm{M}_{\mathrm{Z}}$; then we have

The $\operatorname{Var}\left(\hat{M}_{Y}{ }^{(F)}\right)$ at (6.4) is minimized for

Expression (6.6) clearly indicates that the proposed class of estimators $\hat{M}_{Y}{ }^{(F)}$ is more efficient than the class of estimator $\hat{M}_{Y}{ }^{(G)}$ or $\left(\hat{M}_{Y}{ }^{(g)}\right)$ and hence the class of estimators $\hat{M}_{Y}{ }^{(H)}$ suggested by Singh et al (2001) and the estimator $\hat{M}_{Y}$ at its optimum conditions.

The estimator based on estimated optimum values is defined by
